**General Rules and Regulations for Membership**

1. Membership fees for Life : **-Rs.2001 Rupees Two Thousand one only (Non Refundable Amount )** , Which can be deposited in cash/cheque or online transfer to BSB account given below:-

2. Membership will be awarded for lifetime and will remain active till members are in Bangalore and continue to participate and again on re-joining (returning from other city/state/abroad), the membership will be activated without paying any fee.
3. The decision and creation of BSB is to promote its vision to achieve brotherhood, welfare and growth of Bhumihars as a distinguished and honourable community, without any distinction/discrimination among members whatsoever.
4. Creation of group or subgroup within BSB will not be accepted and involvement in such movement may be liable for termination of membership.
5. The BSB shall be governed by its rules and bye laws, without giving undue importance to the status or financial contribution of a member or any other external factor, which may adversely affect the concept of creation and objectives of BSB. No special consideration will be extended to the members based on their financial contributions.
6. Members are free to give constructive suggestions but the decision of the Executive Committee shall be final. The EC shall be free to take a decision with or without assigning any reason in writing. Interference with the decision of EC shall be liable for termination of the member, after giving him a show cause notice. If EC decides with 2/3rd majority, the decision shall be final and binding on the member.
7. EC shall have the right to formulate rule/s with two- third majority. The addition or modification of rules shall not alter or modify the basic principles of its constitution, vision or objectives.
8. Termination of membership can be based on the recommendation of Executive Committee on the written reference of the members but not less than 20% of total Members and final decision will be taken by committee.
9. Zero tolerance to for anti BSB activities and sexual misconduct. Members found in involvement of any anti-social activities will be subject to termination of the membership to uphold the image of organization.
10. The family members of the enrolled members shall be a part of the community, but they will not be entitled to participate in any official discussion and/or decision making process. Members will make all efforts to invite the members of our community to strengthen the organization.
11. Attending meeting is mandatory for committee members but not for all members, until and unless there is a genuine cause not to attend.
12. EC will debar a member/s from attending a meeting if the person is found to be under influence of any intoxicant.
13. Membership will be awarded on reference of any BSB member only.
